

Cyber & IT Security

From July 1 to July 19, 2019

Overview

This course was crafted to fast-track foreign students into the 21st century's most pressing questions with regard to technological innovations and the adjacent security concerns. From Big Data to Growth Hacking, students will gain knowledge and insight from a 3-pronged approach: traditional class lecture, out of the classroom field visits to relevant exhibits at Paris museums, and total immersion company visits.

The combination of these approaches will give students the opportunity to elaborate a case study in small groups, present them to a panel on the last day of class and get expert feedback on their work.



Course Objectives

The purpose of this course is to expose junior engineering students to a range of contemporary subjects related to data protection and cyber security. To this end, they will study the latest in European legislation on this topic and its real-world application in data-driven firms. At the end of the course, students should be familiar with current events surrounding security and the implementation of security solutions.

Prerequisites and level

Applicants must have intermediate programming skills and completed at least 2 years higher education in IT, computer science or IT



Course grading:

- 20% : Attendance and Participation
- 40% : Mid-Term Quiz (multiple choice questions)
- 40% : Team Project (oral presentation in class) – to be assigned separately
